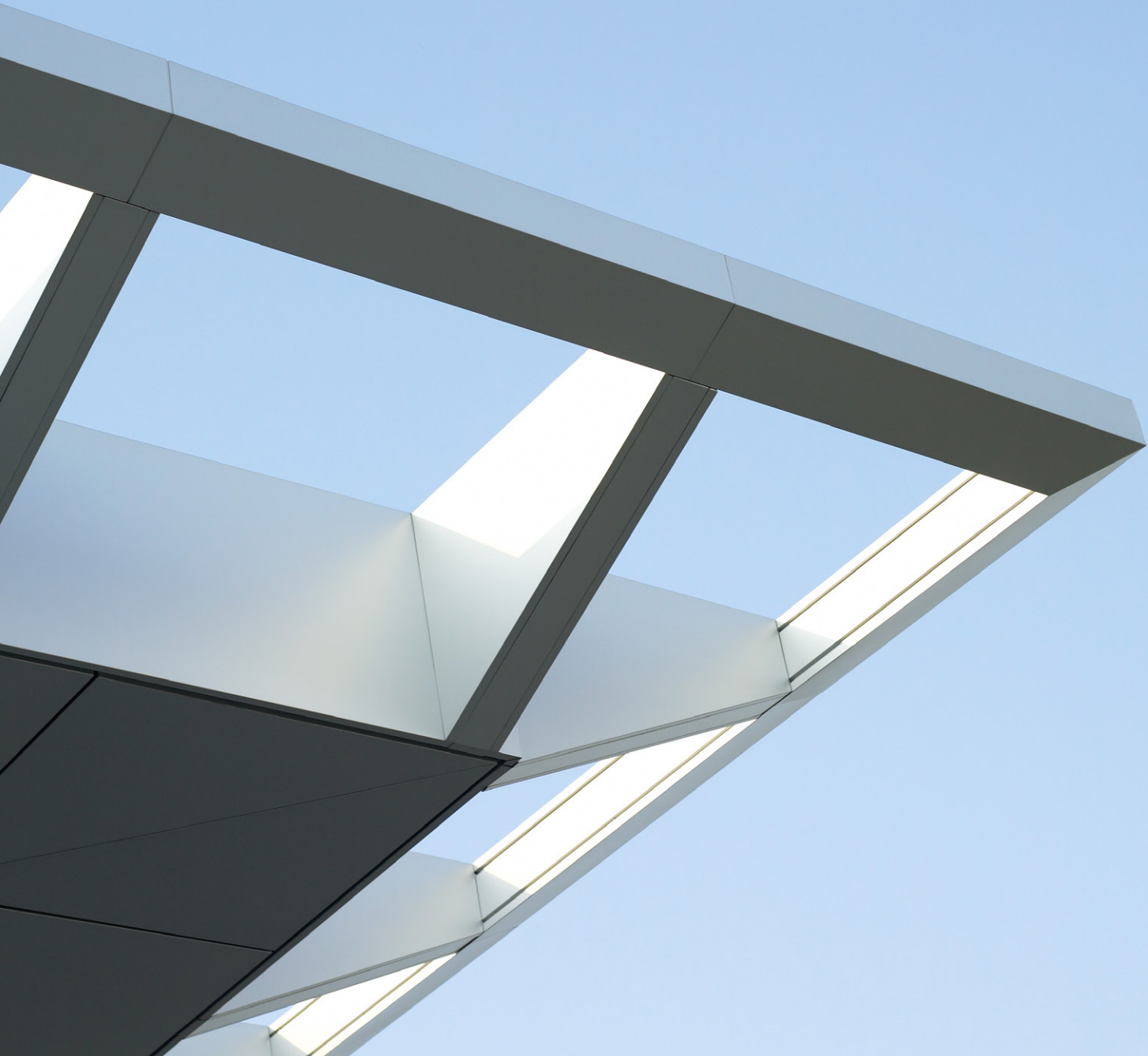

Working remotely

Using secure virtual technology like VPN/RDP/Citrix/ GoTomyPC, our team in India logs into your system and complete the work.

Working in the cloud

This simply requires you to provide your India team the login details. If you still have any paperwork or other supporting documents to pass on to your staff in India, use our secure FTP portal.



We follow a simple 5-step process to do the job

- 01** You will allow us to remotely log in to your system using a secure software or you scan and upload documents to our FTP server.
- 02** We will review the data and start working on the task.
- 03** Once done, we will email you the files for review and feedback.
- 04** We will implement the changes if any, and notify when the task is finished.
- 05** Once you confirm, we will provide a final report of the completed task.

Security Systems / Data Protection /Infrastructure

- › Each team is located in separate office spaces with entry-card access
- › Crossing data is forbidden
- › Highly secure File Transfer Protocol (FTP) server
- › Rapid internet connection (19Mb personal line with 5Mbps backup)
- › Global connectivity (2 x 2 Mb International Private Leased Circuits via different trans-world routing)
- › Secure, remote servers with backed-up data

Physical Security Include

- › 24/7 building security at outside and at office entrances
- › Clear desk policies
- › Biometric attendance systems
- › Magnetic door locking mechanisms at office entrances with access only to department members
- › CCTV surveillance at all entry points and key operational areas

Logical Protection

- › In-house managed email server (not hosted)
- › Incoming / outgoing e-mails are scanned through a cloud-based anti-spam solution
- › McAfee enterprise edition anti-virus / malware software server protection
- › All incoming / outgoing data is controlled by sophisticated firewall
- › Removable storage devices are blocked at workstations
- › Restricted internet sites such as email
- › Transfer of important data is in encrypted form
